<u>Summary:</u> A flexible, dual role responsible for performing pre-operative examinations, high quality surgical sterilizations and needed medical treatments for owned and shelter animals that are in the care of the Humane Society of Charlotte. Diagnosing and creating treatment plans while working in collaboration with the veterinary teams for both basic and emergency care for shelter animals. Collaborating and communicating with the HQHV S/N Veterinarian, Shelter Veterinarian and/or department managers to improve patient care, disease control, surgical protocols, or other medical practices.

Essential Duties and Responsibilities Include:

Clinic Services Duties

- Working knowledge and adherence to Association of Shelter Veterinarians' Veterinary Medical Care Guidelines of Spay-Neuter Programs
- Examine all paperwork and animals' pre-op to determine their ability to withstand surgery, need for testing, changes in protocol, etc.
- Perform surgical sterilizations and other HSC surgeries as requested
- Examine all animals' post-op to ensure appropriate recovery and healing
- Consult with the patient's owners for items of concern or out of the ordinary
- Examine and inoculate animals and provide recommendations for follow up care
- Help assure the use of controlled drugs is being logged and monitored accurately
- Provide post-operative rechecks and order of medical treatments as necessary to ensure complete surgical recovery
- Ensure all clinic staff members are adhering to proper pre-, peri and post-operative care of patients as outlined by the Clinic Services Practice Manager and Spay Neuter Veterinarian
- Provide high-quality preventive and basic care to patients including vaccinations, bloodwork and testing
- Communicate any issues or concerns with the Clinic Services Practice Manager
- Performs special assignments and other duties as assigned when necessary
- Provide excellent customer service to all visitors and clients

Shelter Medicine Duties

- Collaborate with the Shelter Veterinarian to direct, coordinate and perform the screening, diagnosis, and treatment of animals in HSC's care; both basic and emergency medicine
- Monitor herd health and well-being and propose options for increased physical and emotional health of shelter animals
- Create, implement and measure compliance with procedures and protocols to promote efficient and consistent care of shelter animals
- Communicate any issues regarding the disease control protocols, surgical protocols, or other medical issues with Shelter Operations Leadership Team
- Research new protocols and treatments proposing changes to Shelter Operations Leadership Team as needed to maintain high standards of care
- Collaborate with the Operational Leadership Team regarding day-to-day shelter operations, shelter best practices, and animal flow
- Communicate any issues or concerns with the Shelter Veterinary Services Manager
- Advise and train staff, volunteers, and shelter partners on matters within the field of veterinary medicine
